Diversity

Cardozo's Office of Diversity and Inclusion, headed by director Yolonda P. Harrison, works to ensure that all Cardozo graduates have the cultural competency to be effective attorneys and leaders. Outreach to the diverse community of Cardozo law students begins during the Office of Career Services ("OCS") first-year orientation period. This outreach is led by Sherry-Ann Smith-Gomez, Director of Career Services/Coordinator of Diversity Initiatives. OCS holds an orientation session for first-year law students to discuss the importance of diversity and inclusion in the legal profession, in addition to initiatives sponsored by legal employers and professional organizations to which they may apply. These initiatives include: receptions hosted by employers, bar associations, and other affinity organizations; career fairs; scholarships; fellowships; and internships. The OCS Diversity & Inclusion Initiatives webpage on the Cardozo website also highlights these opportunities to students and is updated regularly. OCS staff assists students throughout the application process for many of these initiatives. To inform all students about available diversity and inclusion initiatives, OCS has created a Diversity Listserv via Symplicity. All students are members of the Diversity Listserv unless they actively opt-out through their Symplicity account profile. Students are also informed about diversity & inclusion initiatives through the weekly OCS e-newsletter. OCS takes an active role in encouraging students' participation in career fairs and networking events. Recognizing that networking is often a particular concern for law students of diverse backgrounds, OCS also encourages students to attend annual conferences sponsored by affinity bar associations and student organizations. OCS pays or reimburses to students the registration fees to attend these career fairs and other programs. Cardozo promotes and actively participates in various programs that promote diversity and inclusion. These programs include the Practicing Attorneys for Law Students Program, Inc. (PALS), the NYC Bar Diversity Fellowship Program, the New York County Lawyers' Association Minority Judicial Internship Program, the Joint Minority Bar Judicial Internship Program, the Kenneth G. Standard Diversity Internship Program, and the Leadership Council on Legal Diversity (LCLD) Mentoring Program. OCS provides students with the opportunity to participate in diversity career fairs locally and nationally, including, but not limited to, the Bay Area Diversity Career Fair, Boston Lawyers Group Job Fair for Students of Color, the Black Law Students Association Regional Job Fairs, the Hispanic National Bar Association Career Fair, and the Lavender Law Conference and Career Fair. OCS works closely with our student affinity organizations to develop and co-sponsor career planning workshops and networking events. In conjunction with those programs, OCS provides students with resume/cover letter counseling and mock interview opportunities.

Pro Bono

During our Annual Public Law Advocacy Week (P*LAW), Cardozo students dedicate time to community service. This year, P*LAW Projects included partnering NYS Department of Homeless Services to assist in the annual HOPE count. On their own initiative and with support of the Center for Public Service Law, students have established several programs that provide legal representation to individuals in need. As early as their first year, they are trained to assist domestic violence victims seeking protective orders through the Courtroom Advocates Project (CAP). The Unemployment Action Center (UAC) provides training to students to help laid-off workers navigate the regulatory maze to seek unemployment benefits and advocate before an administrative hearing officer on their client's behalf. Cardozo Youth Advocates (CYA) prepares students to provide trainings to local youth about their legal rights and responsibilities. Through the Black Law Students Association's Incarcerated Mothers Project, students attend monthly sessions at local prisons and assist women with issues relating to the care and custody of their children. The Suspension Representation Project (SRP) provides suspended public school students with law students trained to advocate for them before Suspension Hearing Officers at the Department of Education. Alternative Spring Break Pro Bono Trips also provide students the opportunity to serve on projects outside of New York City. Most recently, students worked over spring break in Baton Rouge, LA assisting local attorneys on right to counsel issues.

Narrative

Cardozo is a highly selective law school in the heart of Manhattan that offers a comprehensive legal education with equal attention to theory and practice. Cardozo's legal partnerships throughout the region helps students develop professional skills and expertise in corporate legal departments, district attorney's offices, law firms, city agencies, courts, and elsewhere. Cardozo students are highly ambitious, energetic and recognized in top law firms for their hard work ethic and practical problem-solving capabilities. Curricular offerings are taught by a nationally recognized faculty composed of prominent scholars and highly successful practitioners, and include Real Estate Transactions, Land Use Regulation, Environmental Law, New York Residential Landlord-Tenant Law, Taxation of Real Estate Transactions, Bankruptcy, Alternative Business Entities and Real Estate Contract Drafting. This is bolstered by a robust real estate externship program launched in 2016, and a speaker series and CLE courses. The Cardozo Data Law Initiative (CDLI) is a groundbreaking program designed to prepare law students for careers in the rapidly expanding legal fields of information governance, e-discovery, data privacy, social media law, and cybersecurity. The CDLI offers a comprehensive program of courses focused on various aspects of data law, taught by faculty at the top of the field. The initiative offers courses encompassed in Cardozo's top Intellectual Property & Information Law Program and the Samuel and Ronnie Heyman Center on Corporate Governance, as well as from data law classes created over the past several years. In addition, the law school's extensive relationships with businesses in the NYC tech sector, as well as Cardozo's new Tech Startup Clinic, provide hands-on experience for students. Cardozo's Center for Rights and Justice brings together the more than 25 programs at the school that advance justice through scholarly research, public policy reform, and advocacy. It will serve as a central base for Cardozo's justice activities, which include coursework, clinics, centers and events. Some of the programs that fall under the CRJ include the Innocence Project, Bet Tzedek Legal Services, Clinic, Cardozo Law Institute for Holocaust and Human Rights, the Civil Rights Clinic, the Consumer Rights Field Clinic, the Criminal Defense Clinic. The Defense Field Clinic at the Bronx Defenders, the Floersheimer Center for Constitutional Democracy, the Holocaust Claims Restitution Program, and many, many more. Cardozo boasts a large active network of alumni and a career services office staffed by seven professional counselors, offering individual assistance with interviewing techniques, résumé writing and job search strategies, as well as workshops and opportunities to learn about a broad range of legal careers. Many of the nation's most prestigious employers recruit at Cardozo. Large law firms, government agencies and other NALP member organizations participated in the 2014 Fall Recruitment Program either through OCI or resume collection. Cardozo alumni are represented at nearly all AmLaw 100 ranked firms. The Resident Associate Mentor Program ("RAMP") is an innovative initiative designed to provide new graduates with opportunities to work as full-time associates at small- and medium-sized law firms and corporate legal departments for one year post-graduation. Participating firms and legal departments hire graduates at a salary similar to a fellowship. Employers commit to train and mentor their Resident Associates for one year. OTHER NOTES Clinical Programs Clinics and other experiential learning options serve nearly 400 students participating each year. During the January intercession, professional skills-building programs serve over 200 Cardozo students in practice areas including one of the most renowned Intensive Trial advocacy programs in the country, a pioneering mediation program, as well as a unique program in transactional law. Some of the clinics include: Alexander Fellows Program & Magistrate Fellows Program; Bet Tzedek Legal Services Clinic; Civil Rights Clinic; Criminal Appeals Clinic; Criminal Defense Clinic; Divorce Mediation Clinic; Human Rights & Genocide Clinic; Indie Film Clinic; Innocence Project; Kathryn O. Greenberg Immigration Justice Clinic; Mediation Clinic; Prosecutor Practicum; Securities Arbitration Clinic; Tech Startup Clinic; and Youth Justice Clinic. Field clinics provide students with hands-on, real-world experience and intensive, critical study of the practice of law, working in small groups under close supervision in selected nonprofit and government law offices in the city and region. They include: Appropriate Dispute Resolution Field Clinic; Art Law Field Clinic; Consumer Rights Field Clinic; Department of Financial Services Field Clinic; Federal Criminal Litigation Field Clinic; Health Care Reform Field Clinic; Immigration Law Field Clinic; Mainzer Family Defense Field Clinic at the Bronx Defenders (BXD); New York City Law Department Appeals Field Clinic; New York City Law Department Juvenile Prosecution Field Clinic; New York City Law Department Labor and Employment Field Clinic; New York State Attorney General Field Clinic (Social Justice Division); Special Education Law and Advocacy Field Clinic; and Strategic Policy Advocacy Field Clinic. Scholarships Cardozo offers a number of Merit based Scholarships including: The Monrad Paulsen Scholarship, named after Cardozo's esteemed first dean, is the most prestigious and highly selective scholarship at Cardozo. It offers guaranteed three-year full-tuition awards and is offered to full-time entering students with exemplary academic credentials who are nominated by the Admissions Committee. The Cardozo Scholars Program awards full-tuition scholarships to full-time entering students with outstanding academic credentials who are nominated by the Admissions Committee. The Dean's Merit Scholarship is offered in varying amounts to entering students nominated by the Admissions Committee on the basis of academic credentials and demonstrated potential for success in the legal profession. The E. Nathaniel Gates Scholarship, named after a former Cardozo professor, recognizes outstanding potential in those who are first-generation graduate students or who come from backgrounds under-represented in the legal profession. Professor Gates, a member of the Cardozo faculty from 1992 until his death in 2006, was the first member of his immediate family to attend college and law school. He served as advisor to important student initiatives and organizations, including the Diversity Coalition and the Black, Asian, and Latino Law Students Association, and at the time of his death was working on a sweeping examination of race in American law dating back to the colonial period. The Cardozo Law Achievement Grant is offered to select entering students, in acknowledgement of academic or professional accomplishments prior to law school. Recipients are nominated by the Admissions Committee. The grant is a one-time offer, awarded during a student's first year, and is not renewable for the student's second and third year. Dean's Distinguished Scholars Program The Dean's Distinguished Scholars Program recognizes exemplary performance after the first year of law school at Cardozo. Students are automatically considered for this distinction, which is typically bestowed on those who place within the top 10% of their first year class. Dean's Distinguished Scholars may receive a new or additional scholarship award for their second and third years at Cardozi
